

#### About the study programme

- The Master's Degree Programme in Inequalities, Interventions and New Welfare State is a crossdisciplinary, international study programme for the Academy of Finland flagship project INVEST.
- INVEST is the only Finnish research flagship in social and behavioural sciences, and it utilises its world-class social and behavioural scientists for teaching and supervising students.
- Includes projects from Social Policy, Demography, Sociology, Psychology and Child Psychology. This makes this multidisciplinary study programme unique both in Finland as well as in Europe.

## Aim of the programme

# During the programme, students acquire knowledge of:

- Key socioeconomic and demographic changes in societies linked with social inequalities
- The role of welfare state institutions and services in compensating and/or enforcing these changes in different country contexts
- A high level quantitative methodological skills for analyzing data on such issues.

#### Structure of 2024–2027 Curriculum

#### 1. Studies in major subject & research, 99 ECTS

- Substantive courses in INVEST research areas
- Methods courses (basic & advanced) to develop skills for thesis and working life
- Thesis and seminars
- Internship (min. 1 month), based on own interests

#### 2. Elective studies, 21 ECTS

= In total **120 ECTS** 

\*1 ECTS = 27 hours of work





# **Study Time**

- Programme is 2 academic years
- Academic year runs from 1 Aug until 31 July
- 2 semesters: autumn and spring
  - ➤ In spring, contact teaching ends around late May
  - ➤ During summer, students can take book exams, work on their thesis, do an internship, return home or stay in Turku.

- The application is open from 8th to 22nd of January 2025 (note: Finnish time)
- Fill the electronic application at www.studyinfo.fi.
- Read the application instructions carefully before the online form opens: https://www.utu.fi/en/study-at

- Prepare for the application process in advance: language test, required documents etc.



#### **General admission criteria:**

- you have a nationally recognized first cycle degree – typically a Bachelor's degree – from an accredited institution of higher education and (if applicable in the country of the degree) from a nationally accredited degree programme
- your degree corresponds to at least 180 ECTS (European credits) or to three years of full-time study
- your degree gives eligibility to master level studies in the country where it was issued

# Programme specific eligibility

- All applicants must have at least a Bachelor's degree in applicable fields of social and behavioural sciences.
- The content of previous studies should be similar/related to the INVEST project. For example:
  - social inequality
  - comparative social research
  - child and youth development
  - welfare state services, benefits, and policy processes
  - population and family demographics
  - prevention and intervention research and quantitative methodological courses (e.g. STATA skills)



#### Student selection

- The eligible applications will be scored based on:
  - The eligible applications will be scored based on their previous studies, work experience, selfintroduction video, and answers to programme specific questions, with a maximum of 45 points achievable.



# **Tuition fees and scholarhips**

- Scholarships are available for student subject to tuition fees
- The scholarships are awarded based on academic merits and success in the programme specific student selection.
- Applying for a scholarship is simple: just indicate "yes" to the appropriate question on your online application form for the programme.
- Information regarding the scholarship decision is included in the admission offer for those admitted to the programme
